Targeted Support to Territorial Development in a RIS3 Context

Key issues

Governance

- Need for more participatory (RIS3) governance
- Administrative, legal and technical issues
- Structural bottlenecks in the R&I ecosystem
- Coordination problems

Capacity building

- Need for qualified human resources
- Enhanced business sector capabilities for innovation and entrepreneurship
- Need for openness to overcome weak integration in EU networks
- Infrastructure

Innovation

- Weak links between academia/PROs/ business
- Limited use of available funding for R&I
- Limited use of research infrastructures

JRC projects

Enhance capacity - *Lagging Regions*

- Support implementation of RIS3
- Support EDP capacity and RIS3 governance
- Develop human resources and mobility


Support to universities – *HESS Project*

- Align higher education with regional economy
- Strengthen role of education in RIS3 and regional innovation systems

Access funds - *Stairway to Excellence Project*

- Analytical support: Policy Insights; Joints Statements; Country Reports; Facts & Figures; Synergy Examples
- MA training to build capacities
- Collaboration between regions and EIT KICs (Regional Innovation Scheme)
- Collaboration between MSs/regions & Joint Undertakings

Lagging Regions: Objectives

- to develop and provide appropriate and specific support to selected regions in RIS3 implementation, building on EDP
- to develop and enhance linkages between RIS3 at regional and national levels
- to develop and implement horizontal approaches to key issues in the growth and governance of RIS3 (e.g. monitoring)
- to develop and disseminate lessons and a tool box for other EU regions
- to improve understanding of slow and limited growth in EU regions and links to macro-economic framework conditions

- **BG** - Severen Tsentralen (focus – Gabrovo/ Ruse)
 - *Governance/2 innovation camps/EDP mechatronics*
- **RO** - Nord-Vest and Nord-Est
 - Several EDP focus groups/PDLs/national **level/technology transfer supply and demand**/HR mobility/call support
 - *Roll out to all regions – 2018-9*
- **HU** - Észak-Alföld (focus – Hajdu Bihar)
 - *expert study/collaboration with INNOVA/thematic platforms event*
- **PL** - Warmińsko Masurskie
 - *2 EDP events 2018 (food – February, wood/furniture – June)*



Specific Support in partner regions

- **EL** – Eastern Macedonia and Thrace + spill-overs in all EL
 - *Workshop on cross regional learning, Crete, Feb 2018*
- **IT** – Puglia
 - *Workshop on funding synergies/MOOC contributors/researchers' career consolidation*

 - *EDP focus group on wine value chain/joint EDP with Extremadura (self-organised)/Regional helix conference*

 - *Monitoring and stakeholders- MOOC contributors/calls analysis/Beyond EDP*



Lagging Regions: Horizontal Activities

Governance

- long-term sustainability of the EDP process
- relationship between national and regional levels
- synergies between structural funds and other resources
- questionnaire survey & working group – **February & May 2018**

Monitoring and evaluation

- Working Group – experts and Mutual learning
- Development and launch of MOOC – **March 2018**

Impacts

Trust building and commitment

- Willingness/openness to collaborate
- Sustained commitment & increased trust in quadruple helix
- Approach 'exported' to other regions

Enhanced understanding of RIS3

- Focus on the process and the ideas emerging
- Align regional strengths, international trends & opportunities

Participatory capacity building

- Increased participation of stakeholders in policy activities (EDP focus groups, working groups, online consultations)

Identifying Challenges

- Legal and administrative (eg State Aid)
- Capacities and experiences

Projects and Calls

- Concrete project ideas and partnerships
- Support to calls

The road ahead ...

- Lagging Regions end June 2018 ... but next phase of lagging regions is in the pipeline
- Roll out of Romanian activity to ALL regions –end of 2018
- Ongoing close complementarity with S2E and HESS
- Lessons for transition regions
